 - **6:00 PM: Mandatory meeting** (Show Competition Rule 10.04) including Chief Judge, Representative from each team, and others as invited by Chief Judge.
Failure to have a team representative present may result in a \$200 fine.

- 5:00 - 10:00 PM: Grill & Beer Garden Open

Saturday, July 8

- 8:00 AM: Individual Competition (Swivel, Doubles, Team Jump, Freestyle Jump)
